**RE: Final Environmental Impact Statement for Hydropower License Surrender
Kilarc-Cow Creek Hydroelectric Project (FERC Project No. 606)**

Dear Ms. Bose:

Pacific Gas and Electric Company (PG&E) has reviewed the Final Environmental Impact Statement (EIS) for the Kilarc-Cow Creek Hydroelectric Project, FERC Project No. 606 (Project), issued on August 16, 2011. PG&E concurs with the recommendations presented in the Final EIS and believes the Federal Energy Regulatory Commission's (FERC's) analyses are well supported by the available data.

PG&E supports FERC's intention to include in the License Surrender Order the exact language of the original Protection, Mitigation, and Enhancement measures (PM&E measures).¹ PG&E's comment letter on the Draft EIS (dated August 25, 2010) explained the importance of including the exact wording of the PM&E measures in the License Surrender Order, and noted that these PM&E measures were carefully developed in consultation with the resource agencies and through outreach with landowners and other stakeholders. If the exact language of any PM&E measure is summarized or altered in the License Surrender Order, the effectiveness, feasibility, and clarity of that PM&E measure may be inadvertently impaired. Furthermore, the wording of many of the original PM&E measures were included in FERC's Biological Assessment, and are now part of the project description upon which National Marine Fisheries Service (NMFS) based its Biological Opinion.

If FERC wishes to modify any of the language contained in the original PM&E measures, PG&E would like to work with FERC and resource agency staff to develop language that meets FERC's objectives while preserving the carefully negotiated intent of the proposed PM&E measures.
